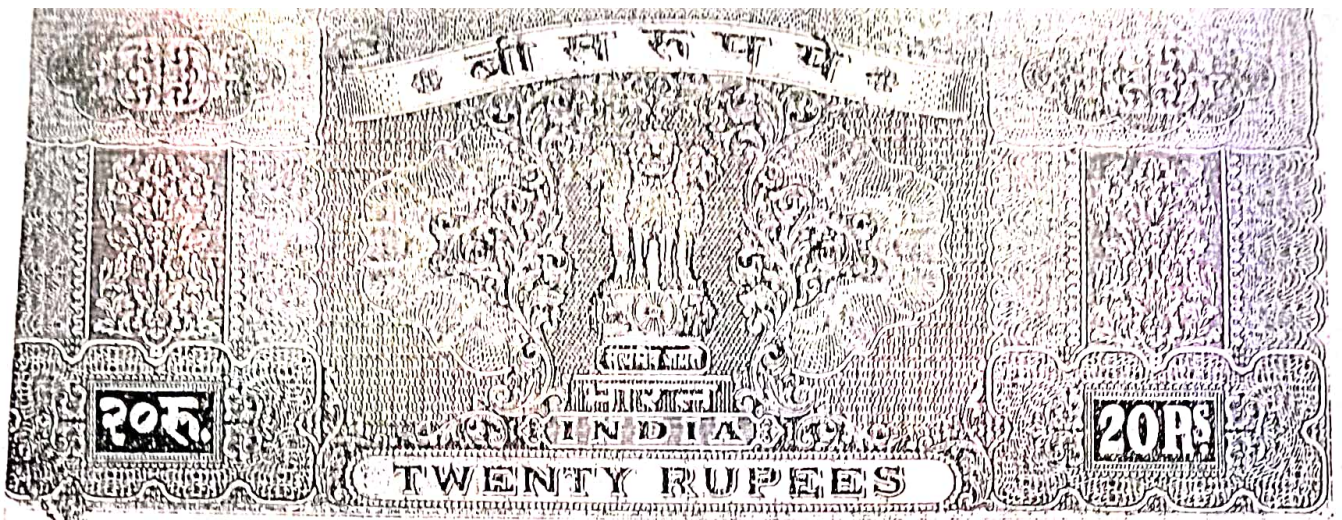

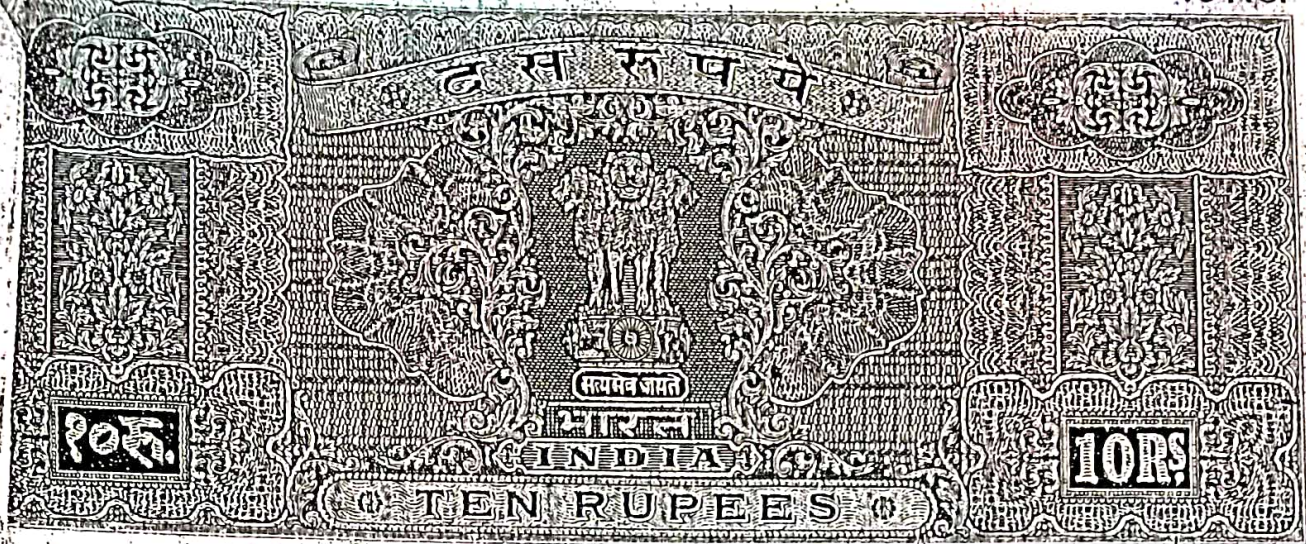

1) To establish, run and maintain educational institutions including colleges, polytechnics, medical, engineering, Training and Research

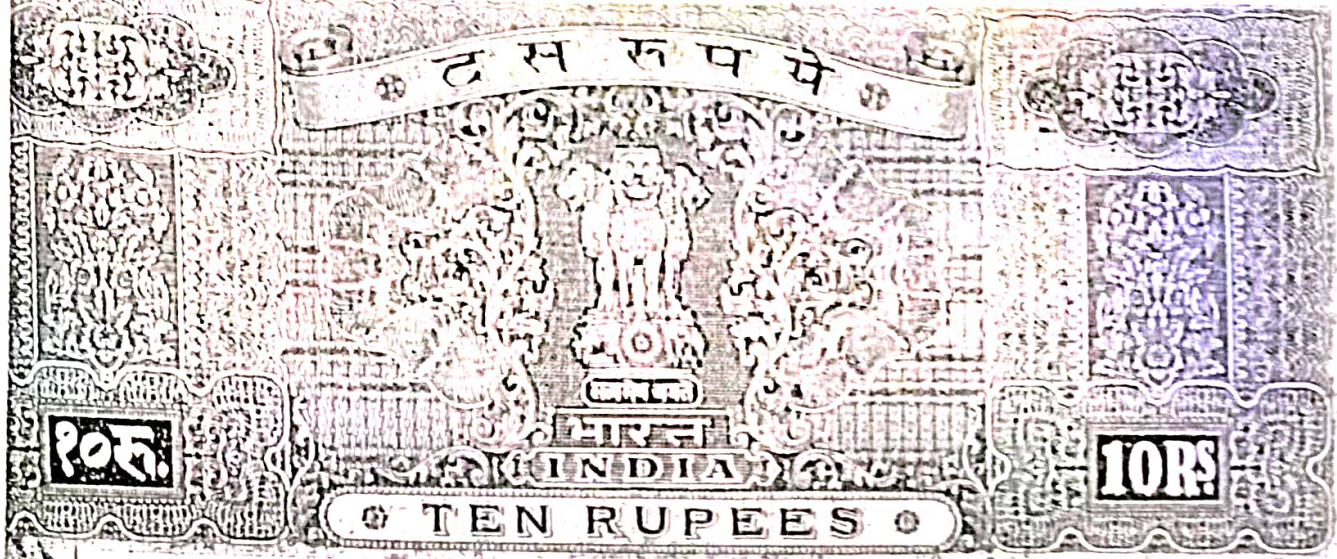

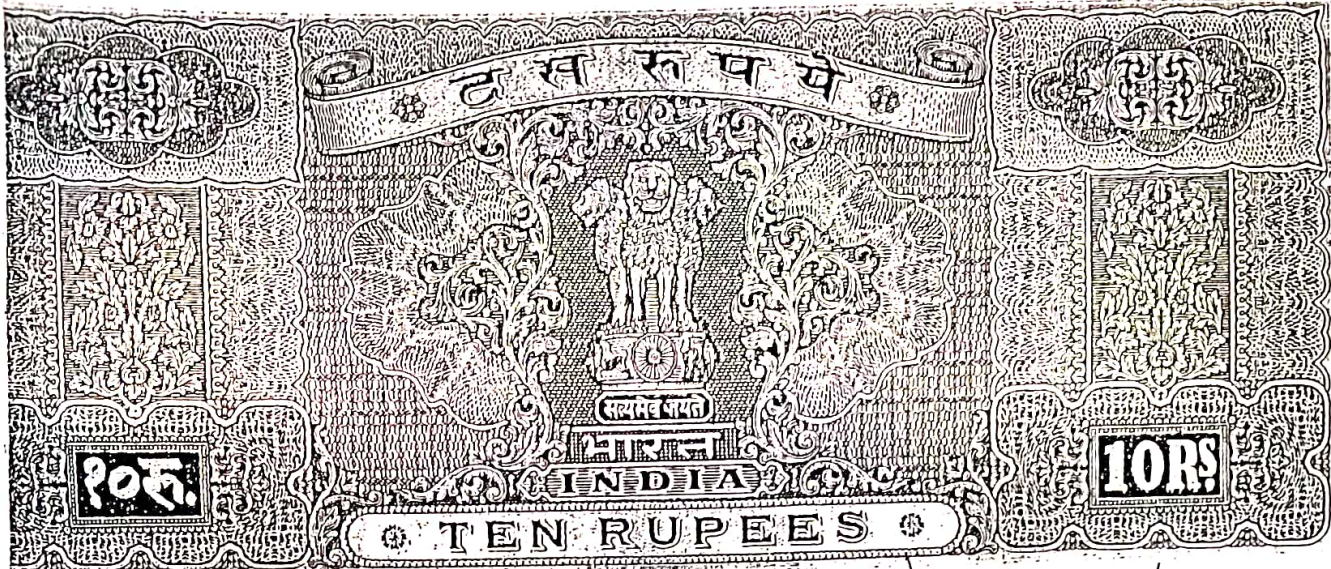

d) The above Trustees shall hold office along with the 6 nominated Trustees for their life time or until they resign as Trustees of the Trust.

e) Any vacancy in the Trust Board may be filled up by Co-option by the surviving or remaining Permanent Trustees of the Trust Board. In case of difference of opinion the view of the majority of the Trustees of the Trust Board shall prevail in the nomination of a new Trustee to fill up the vacancy in the Trust Board.

4(a) The following are the office bearers ~~of~~ who shall be members of the Trust Board and who are nominated out of the members of the Trust Board.

- 1) Chairman of the Trust Board.
ii) Secretary to the Trust
and iii) Treasurer to the Trust.

b) The Trust Board may allocate and distribute the work of the Trust to the above office bearers from time to time.

c) The Trust Board may appoint additional office bearers or other officials as may be found convenient from time to time either from the Members of the Trust Board or from others having qualifications prescribed by the Trust Board from time to time. Such additional office bearers as stated above shall hold office at the discretion of the Trust Board.

i) The manner of and conditions under which donations or other amounts may be received for the Trust and its objects

ii) The powers and duties of office bearers and other officials and employees of the Trust and its institutions.

and iii) Such other matters as may be necessary for carrying out the terms of the Trust.

5) The following are the disqualifications to become a Trustee of the Trust.

a) Persons convicted of an offence for a period exceeding 3 months.

b) Persons who are less than 30 years old.

c) Persons in Government services (either state or Central).

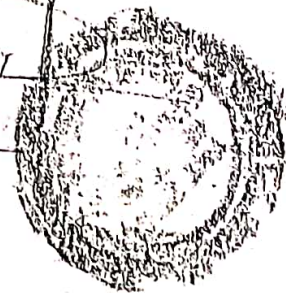

6) The Board of Trustees are entitled to open a bank account or accounts in the name of the Trust or that may be opened in the name of various Educational Institutions and such account or accounts may be operated by any one or more of the Board of Trustees as may be decided from time to time.

7) The Board of Trustees are authorised to borrow monies for the purposes of the Trust with or without security from Banks, Financial Institutions or others and also have the power to offer as security any immovable or movable property or other assets of the Trust.

8) The Board of Trustees have the power to employ persons to carry out the objects of the Trust and also the power to dismiss or dispense with the services of such persons.

9) The Board of Trustees are authorised to acquire, land, buildings or other immovable property for the Trust with the funds of the Trust and for the purposes and the objects of the Trust.

10) The funds of the Trust shall be invested in accordance with the provisions of the Income-tax Act or as may be required as per Regulations made under the Income-tax Act as the case may be.

11) The Board of Trustees are authorised to sell, lease, mortgage, or ~~or~~ otherwise deal with any property of the Trust

12) The Board of Trustees are entitled to collect funds through contribution or any other manner to augment the resources of the Trust.

14) Proper accounts shall be maintained for the Trust which shall be audited by a Chartered Accountant - Account shall be maintained on an annual basis and audited account shall be placed before the members of the Trust and on an annual basis but there is no need to pass the said account by the members.

15) It is hereby declared for the removal of doubts that the objects of this Trust is not for the benefit of any particular religious community.

16) It is hereby declared that in the implementation of the objects of the Trust or of the conditions of the Trust the decision of the Board of Trustees shall be final and cannot be called into question by any person whatsoever.

17) The funds of the Trust are as under:-

i) The initial contribution of Rs.1,000/- as aforesaid.

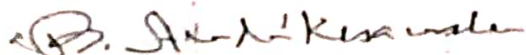

in cash or in kind.

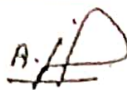
20) This Trust is irrevocable.
